

Instructions on filling out the petition

IMPORTANT: Michigan law mandates that petitions must be printed on legal (8 1/2" x 14") paper otherwise they will be deemed void.

The signers must write in the City or Township where they are registered to vote and check the appropriate box. Villages and unincorporated areas are always within townships.

The circulator must write in a county name at the top of each petition form. Make sure that all signers are registered to vote in that county. You may circulate petitions for any county in the state, but a different petition form must be used for each county.

The signer must sign his or her **full name** in the same form as when they vote (i.e., Mrs. John Jones is incorrect; Mary Jones is correct) and then print his or her name.

In this space, the signers should write their house number and street name or rural route. **Post office box numbers are invalid.**

The signer must include the zip code in the space provided.

The signers must also write in the date when signing the petition.

INITIATION OF LEGISLATION
 An initiation of legislation to amend the Use Tax Act, Public Act 94 of 1937, by repealing section 34 (MCL 205.936).
 THE FULL TEXT OF THE PROPOSED LEGISLATION IS AS FOLLOWS: Enacting section 1. Section 3d of the Use Tax Act, 1937 PA 94, MCL 205.936, is repealed.
 This proposal is to take effect December 15, 2007.

Warning - A person who knowingly signs this petition more than once, signs a name other than his or her own, signs when not a qualified and registered elector, or sets opposite his or her signature on a petition, a date other than the actual date the signature was affixed, is violating the provisions of the Michigan election law.

 I, the circulator of this petition, attest that I am qualified to circulate this petition, that each signature on the petition was signed in my presence and that, to my best knowledge and belief, each signature is the genuine signature of the person purporting to sign the petition, the person signing the petition was at the time of signing a qualified registered elector of the city or township indicated preceding the signature, and the elector was qualified to sign the petition.

WARNING - A circulator knowingly making a false statement in the above certificate, a person not a circulator who signs as a circulator, or a person who signs a name other than his or her own as circulator is guilty of a misdemeanor.

After the circulator has gathered signatures he or she must complete the section in the lower right of **each** petition form. **No signatures may be added to the petition form after this portion has been completed and dated.**

Please also note:

- Petition forms are acceptable with at least one but no more than fifteen signatures. The circulator may be a signer of his own petition form.
